



Terms & Conditions

Payments

Prices are subject to change, please check before booking for current rates. By paying any part of the invoice the hirer is also agreeing to the Terms & Conditions. A \$200 non-refundable deposit is necessary to secure the event time and date for the Photo Booth, a 30% non-refundable deposit is required for all other hire items and balloons. Until a deposit is received the date cannot be confirmed. The outstanding amount must be paid by the hirer to Birdie Party Bling at least 10 days prior to the event. If booked within 7 days of the event, non-refundable full payment must be received by Birdie Party Bling within 48 hours of booking. A travel surcharge may apply to event further than 35km from Orange CBD. Late payments exceeding 30 days from event will incur late payment fees of \$100 per month until the invoice is paid. An idle fee may also apply for extensive waiting periods. Certain dates may be subject to additional surcharge. Fancy dress props (if used) must be in good order at the end of the event otherwise a charge may apply.

GST

All prices are exclusive of GST unless otherwise stated.

Cancellation

All deposits are non-refundable. If the hirer cancels within 30 days before the event date the deposit can be held in lieu for a future booking. Prior notice is required of changes to the date and time of the event. Birdie Party Bling cannot be held responsible for unforeseen delays at the venue.

Privacy

Birdie Party Bling will not sell your details to any third party and will take reasonable measures to ensure that your details remain confidential.

Hiring, Delivery & Service

Local delivery, set-up and removal of the equipment are free of charge. Time taken to deliver, set-up and remove the equipment will be outside the rental period. A travel fee may be applied for events outside the Orange local area.

For the Photo Booth; the Booth Attendant will aim to arrive an hour prior to hire time to set-up. Earlier set-up time can be arranged in discussion with Birdie Party Bling and an idle fee may be applied to a set-up time much greater than the allocated hour. A trained Photo Booth Attendant will be within close proximity of the equipment at all times to ensure smooth running. The hirer will be liable for any damage caused to the equipment (Photo Booth/Props/Backdrop) within the duration of the hire. Birdie Party Bling's Photo Booth Attendant may stop the usage at any time during the event if they feel the equipment is being misused in a way that is dangerous to any persons or potentially damaging to the equipment.

Use of Images

When hiring from Birdie Party Bling, the hirer gives permission for images taken at the event to be used on Birdie Party Bling website and social pages and for advertising purposes unless advised prior to the event that the hirer would not like their images used. Birdie Party Bling will not use images that are deemed unsuitable on their website, social pages or for advertising and will not use any content that may be personally damaging to any person/s.

Force Majeure

Birdie Party Bling will not be liable for failing to perform under the Agreement by the occurrence of any event beyond Birdie Party Bling's reasonable control, including a labour disturbance, internet outage or interruption of service, communication outage failure by a service provided to us to perform, fire, threatened or actual act of terrorism, natural disaster or war.
